bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

4. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. The Terms and Conditions of special conditions of the contract shall prevail over the terms and conditions of GeM bid / GCC / SLA.

2. There are 46 cable TV connections in Silent Spring Hostel NIPHM. Cable TV services are required for all these 46 Televisions which shall include comprehensive maintenance / repair / replacement of Dish, cable, set top box, remote and any other accessories required to keep the Cable TV line operational
3. The Cable TV Network shall include the following channels:
 - a) All Free to Air Channels
 - b) Atleast one Regional Channel in each regional languages (in India)
 - c) Atleast two News Channels both in English and Hindi
 - d) Nominal number of Paid Channels (covering National & International News, Sports, Regional, Music, Movies, Entertainment, Lifestyle, Food etc category)
 - e) The Pack shall contain at-least 2-3 Channels in each category in above aspects. The suggestive/indicative list of channels is enclosed for kind reference at Annexure A & B of ATC
4. The Service Provider shall possess valid authorized distributorship/Franchise/Licence of providing cable TV/DTH services
5. The payment option to be made monthly basis against submission of bills and satisfactory delivery of services at NIPHM Hostels
6. The requirement of connections may increase or decrease in future.
7. The technical problems of cable subscription must be sorted out same day within 6 hrs of complaint being lodged by NIPHM
8. The Service Provider shall install/remove a new connection within two working days of intimation by NIPHM
9. Documentary evidence to be submitted. The following documents can be considered as evidence towards availability of office in the state of consignee:
 - a. Firm Registration Certificate.
 - b. Labour Registration Certificate.
 - c. Notarized rental agreement
 - d. Telephone bill. (or) Electricity bill.
 - e. Other document / certificate issued by the statutory authorities.
 - f. Blanket declaration of availability of office in the state of consignee without proper proof or on the Company letterhead or any other except the above, shall not be considered and the bids of such bidders shall be summarily rejected.
 - g. The office of the successful L-1 agency will be physically verified if required by NIPHM.
 - h. The information being found false or incorrect at any stage, bid shall be liable to rejection/termination of accepted Bid /any further action in accordance with GeM GTC

10. The number connections will be varied every month depending on the requirement (schedule of training programs) and payment will be released for the recharged number of connections only on monthly basis.

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 25% of total value.

9. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any

Category item bunched with it.

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
